2 **IT IS HEREBY ORDERED THAT:**

- 3 1. Defendant EXECUTIVE EVENT SERVICES, LLC, must provide to Plaintiff's
- 4 counsel complete, code-compliant responses, without objections, to Plaintiff's
- 5 Form Interrogatories, Set One, within twenty (20) days **after service**
- 6 Order to be prepared by Plaintiff.
- 7 2. Defendant EXECUTIVE EVENT SERVICES, LLC, must provide to Plaintiff's
- 8 counsel complete, code-compliant responses, without objections, to Plaintiff's
- 9 Form Interrogatories, Set One, and Requests for Production of Documents, Set
- 10 One, within twenty (20) days **after service** ~~of the date~~ of this Order. These responses must
- 11 include all documents responsive to these requests that are within Defendant's
- 12 possession, custody or control.
- 13 3. Defendant EXECUTIVE EVENT SERVICES, LLC, is ordered to pay to Plaintiff's
- 14 counsel sanctions in the amount of \$2,000, for the fees and costs incurred in
- 15 preparing, filing, and arguing this Motion, within twenty (20) days **after service**
- 16 Entry of Order to be prepared by Plaintiff.
